

## **MARITIME DISTRICT OF ARBATAX**

### **ORDINANCE 35/2016**

#### **EXTRACT OF NAVIGATION RULES**

##### **Article 39 Navigation within the ports, the work and the waters of the Area**

1. Recreational units shall be prohibited:

- a. stay at less than 100 feet from the mouths of all ports and landings tourists in the Circondario;
- b. approach and stay less than 200 meters from merchant ships and less than 300 meters from military ships to the base;
- c. enter, exit and circulate within the port of Arbatax and the remaining tourist destinations of the Circuit at a speed of more than 3 knots;
- d. circular sailing propulsion within the ports, except for well - founded reasons safety related to engine failure. Pleasure craft equipped with only sail propulsion will have to navigate within ports exclusively to trailer of engine units, subject to specific authorizations issued by the Head of the Maritime Circondary to sports clubs;
- e. approaching less than 50 meters from booms, gavitelli or other floating signals or ad regularly reported fishing facilities;
- f. to sail and stay in the sea section primarily for bathing, to of this Ordinance;
- g. navigate, anchor, stay, and any other type of activity within mirrors waters which are prohibited by navigation with special orders issued by the Authority Marittima.
- h. stay at the unattended base, ie without the driver / commander or others persons / crew members aboard or in the immediate vicinity (such as allow at least visual contact and prompt intervention in case of sudden worsening of weather conditions or controls by the Forces of Police) for more than 30 minutes.

2. Recreational inbound and outbound units must keep straight ahead of the halfway through the mouth, avoiding blocking the maneuvers of merchant vessels and / or military, to which they must always give priority.

3. For the purposes of this Article, port water seals shall be considered as those covered between the ends of the respective perforated dams.

4. In no case shall the rules for avoiding boarding at sea be denied Law 27 December 1977 No. 1085.

## **Article 40 Mooring, sailing and picking up within the harbor seaports**

1. Recreational moorings moored at the ports and landings of the Arbatax Maritime District must be permanently guarded by persons / crew members, identified by the commander / owner of the unit, or by employees of the area managers in concession, with guardianship, capable of facing any emergency.
2. Launching and launching of recreational units by lifting means (cranes and cranes) similar) in non - concession areas, within the ports of the Maritime District of Arbatax, must be obtained prior to the authorization of the Maritime Authority, subject to any exceptions specific regulations already provided for by specific ordinances.
3. It is forbidden to block in any way the access to the public slides, preventing the yachting and take out units.
4. Recreational mooring mooring within the port of the Circondary is prohibited if this does not is expressly permitted; in any case it is forbidden to give anchor to the anchors, if not in case of breakdowns / emergencies, and for the time strictly necessary for the resolution of themselves.
5. Recreational units in transit at the port of Arbatax, who do not intend to moor at concession-free berths, can moor at the dock Central (if the stay does not exceed 12 hours) Maritime Circuit Office of Arbatax, to be requested by radio or by contact telephone to the operating room.

## **Article 41 Speed limits and special requirements**

1. In the waters of the Arbatax Maritime District, outside the sea areas destined for bathing and up to 500 meters from cliffs / shores or 1000 meters from the beaches, all navigation units must hold a speed not exceeding 10 knots with hull, however, not in planta, but in displacement.
2. In the ports of the Maritime District of Arbatax it is forbidden to use the toilets on board if the recreational unit does not have suitable collection containers for its slurry.
3. In the waters of the Arbatax Maritime District it is forbidden: a. pour into the sea any type of pollutant and, in particular, hydrocarbons, hydrocarbon mixtures, including bilge water; b. use non-biodegradable detergents or detergents for the washing of recreational units, where such use involves the discharge into the sea of such substances; c. stay or anchor, from 20:00 to 08:00, with no recreational facilities suitable collection containers for its slurry. With regard to sea-water discharges, the provisions contained in the Order N are unchanged. 14/2011, dated 24.02.2011, cited in the foregoing.
